This GUARANTY shall be binding upon the heirs, representatives, successors and assigns of Guarantor(s) hereby waive any homestead exemption and all requirements or rights with regard to notice, demand, presentment, or protest and appoint any employee of Leff Electric or attorney to appear in any court of competent jurisdiction for the purpose of confessing judgment on all amounts due pursuant to this GUARANTY.

Guarantor(s) recognizing that their individual credit history may be a factor in the evaluation of accepting this GUARANTY, hereby consent to and authorize Leff Electric to obtain and use (from time to time on an "as needed" basis) any and all information related to the credit evaluation process, including but not limited to, the Guarantor(s) consumer credit report.
